Security concerns also emerge as a significant focal point for participants during large events, such as the YMR. Feedback reveals a shared sentiment regarding the

importance of establishing secure environments to ensure attendees' safety and protect their belongings. Insights from Taylor and Das (2010) underscore the relevance of these concerns; any ambiguity or reported breaches can lead to heightened anxiety among participants, which may diminish opportunities for engagement and participation. Ensuring robust security measures is paramount for maintaining attendees' trust in the organizers and safeguarding the initiatives' objectives.

Another area of consideration pertains to time constraints. Many attendees reflect on the retreat's relative brevity and express a desire for more extended engagement, coupled with more substantial follow-up opportunities. Knowles's (1984) research on adult learning theory emphasizes the importance of spaced repetition and practice for effective learning. Feedback indicates that the limited timeframe of the YMR may restrict attendees' ability to thoroughly absorb, comprehend, and apply the principles discussed throughout the sessions, potentially resulting in a more superficial understanding of the material.

Participants have also highlighted infrastructural and technical challenges that can impact their overall experience. Insights gathered from feedback reveal that issues such as insufficient ventilation and audio system problems are areas of concern. Hall (2015) highlights the necessity of having reliable infrastructure and efficient technical systems to facilitate successful event management. When logistical failures occur, they can detract from the program's quality and significantly impact participants' experiences.

Another point raised by attendees pertains to the clarity of objectives and expectations surrounding the YMR. Many participants have noted that clear communication regarding the event's goals is essential for meaningful engagement. Locke and Latham's (2002) goal-setting theory reinforces the importance of defined outcomes for achieving success. When event organizers clearly articulate the objectives, it helps attendees understand what they can expect to gain from the experience, fostering a more engaged and purposeful atmosphere.

Staffing imbalances have also been identified as a concern among participants. Feedback reflects those certain areas may experience understaffing, while other segments have an abundance of volunteers. Research by Hackman and Oldham (1976) highlights the importance of adequate staffing and resource allocation in enhancing both volunteer engagement and participant satisfaction. An equitable distribution of staff can promote efficiency and encourage active participation, thereby boosting the overall effectiveness of the initiative.

Lastly, many attendees have expressed a desire for more personalized attention and basic amenities during the retreats. This feedback underscores the importance of addressing fundamental requirements, such as safety and comfort, which are crucial for achieving overall satisfaction and well-being, as outlined in Maslow's (1943) theory of human motivation. Ensuring that these basic needs are met is vital for participants to feel valued and appreciated during their experience, ultimately enhancing their perception of the retreat's quality.

DISCUSSION

empowerment and participation is deeply rooted in theological principles that underscore the necessity of actively involving young individuals in the church's mission. Moreover, investing in infrastructure and technical resources is critical for the success of these initiatives.



Ensuring all infrastructure, including sound systems, venues, and ventilation, is in optimal condition prior to events can significantly improve the participant experience.
